## Youth Futures Education Fund

The Youth Futures Education Fund (YFEF), held at the Vancouver Foundation, was established to provide low-barrier access to funds that provide assistance with living expenses to youth who are attending a post-secondary institution on a tuition waiver.

Funds are distributed on a first-come, first-serve basis, and are non-taxable. The maximum amount of grant funding any one student may receive is \$500 per semester (\$1,000 max per program year). The inclusion of supportive documentation of expenses with the application is preferred and may be required at the discretion of the Financial Aid Officer. The YFEF may be accessed by eligible students to meet financial needs for such expenses as books, educational technology, living expenses, financial emergencies, etc.

## Eligibility Criteria:

To be eligible for the Youth Futures Education Fund, students must meet the following criteria:

- 1. Be a CMTN student sponsored by the BC Provincial Tuition Waiver program;
- 2. Enrolled part-time or full-time in any CMTN program;
- 3. Demonstrate financial need;
- 4. Be in good standing, attending class on a regular basis, and progressing satisfactorily. (Exceptional circumstances that prevent students from being in good standing or attending will be considered on a case-by-case basis.)

## Procedure:

- 1. Complete the application in full and attach any supporting documentation.
- 2. Submit the application to the CMTN Financial Aid Officer.
- 3. Upon review of your application, you will be notified by email of the decision.
